**Subject: Changes in Membership Subscriptions and other information request.**

Dear all,

Greetings from DSRA! As you are aware that the new elected body of Delhi State Rifle Association took office on 28 January 2023 and has decided to streamline the functioning of shooting clubs / associations in Delhi. As a partner organisation of DSRA, we wish to apprise you of the decisions taken by the Governing Body in their meeting held on 12 March 2023, as follows:

1. DSRA is digitizing all its records of members and this requires uploading of Membership Cards as the identity document of shooters. It has therefore become necessary to initiate the following changes to bring in uniformity with all affiliated units of DSRA. With effect from 01 April 2023, all Clubs / Associations affiliated to DSRA will be required to adhere to the following:
  - a) Issue **Membership Cards** to all their members.
  - b) Membership Cards should have respective Membership Number, recent Photograph, Name, Father's Name, Residential Address, Date of Birth, Validity and signature of Member.
  - c) All Membership Cards will be issued under signature of President or Secretary of the affiliated Club / Association.
2. Details of all shooters will have to be sent to the Hony. Secretary, DSRA by the 1st week of April, along with a Service Fee of **Rs. 200/- (inclusive of GST) per shooter**. This fee covers the services that DSRA provides to the shooters all through the year, for each respective competition, issue of certificates, recommendations, etc. The list should be sent to the DSRA via email in tabulated Excel format with the same information as listed in point 1(b) above. **Only those shooters whose names are sent to us with the Service Fee will be approved for participation in competitions.**
3. All affiliated institutions of DSRA who have not paid their Membership subscriptions will be temporarily suspended and their shooters will be debarred from DSRA member privileges and will not be approved for upcoming competitions.
4. The Membership Subscription Fee for all affiliated units of DSRA stands revised to **Rs. 3,000/- + GST** from 1st April 2023. The following details are also required to be submitted:
  - a) List of current members of Governing Body.
  - b) Names and designation of signatories to Bank Account of the Club / Association.
  - c) Date and minutes of the last Governing Body Meeting / Annual General Body meeting.
  - d) Dates and list of matches conducted by the Club / Association in the last 2 years.

It is requested that the above requirements may be fulfilled at the earliest so that DSRA is able to ensure smooth functioning and interactions with affiliated Clubs / Associations.

DSRA extends its warmest regards to all.
